Guidelines for understanding your data processing agreement with itm8

#### 1 Introduction

A data processing agreement is a crucial part of data protection regulations that ensures that personal data is handled responsibly and in accordance with applicable laws and regulations.

In this guide, we will walk you through how to read your data processing agreement in the context of the appendices that are relevant to your processing activities.

The aim is to give you a clear and precise understanding of the content of the agreement so you can ensure your organisation complies with data protection obligations.

### 2 Access to the data processing agreement

When you enter into a data processing agreement with itm8, you access the data processing agreement via a link in your agreement with itm8.

In your agreement, the link will appear under the section "Personal data processing", which states that the agreement is available on itm8's website, as shown below:

The Processing Activity is subject to Supplier's data processing agreement available on Legal & Compliance in itm8 (the "Data Processing Agreement"). The Supplier's Data Processing Agreement takes precedence over the Agreement with respect to matters relating to Supplier's Processing Activities and only these.

Clicking on the link will take you to itm8's website "<u>Legal & Compliance in itm8</u>". On the page there is a reference to itm8's data processing agreement here:

# Data Processing Agreement

In the event that itm8 is acting as a data processor for customers under an agreement (hereinafter "Service Agreement"), and unless otherwise agreed upon in the Service Agreement, any processing activity in terms of Article 4(2) of the General Data Protection Regulation (GDPR), will be subject to the itm8 Data Processing Agreement (hereinafter "Data Processing Agreement") included in the link below. Itm8's Data Processing Agreement serves as an integrated part of the applicable Service Agreement, including subsequent agreements on Services entered into between the parties in accordance with the Service Agreement. Itm8 A/S's Data Processing Agreement is based on the Danish Data Protection Agency's standard contractual provisions pursuant to the data protection regulation, Article 28, as these were published in December 2019.

## 3 Information about the processing - Appendix A1

To see information about the processing agreed with itm8, look in the preamble of the data processing agreement, under section 2.8, where there is a link to Appendix A1.

#### 2 Preamble

- The Customer has entered into an Agreement ("Service Agreement") with the Supplier and the performance of the agreed Services ("Services") is subject to these Conditions.
- These Clauses relate to the processing activity(ies) ("Processing Activity") agreed in the Service Agreement.
- 3. In connection with the provision of Services, the data processor processes personal data on behalf of the data controller, which is why the parties have entered into this Data Processing Agreement and its appendices (collectively the "Data Processing Agreement"), which forms an integral part of the parties' Service Agreement.
- 4. These Clauses set out the rights and obligations of the data processor when processing personal data on behalf of the data controller.
- 5. These Clauses are designed to enable the parties to comply with Article 28(3) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).
- 6. The Clauses take precedence over any corresponding clauses in other agreements between the parties.
- These Clauses are accompanied by appendices and the appendices form an integral part of the Clauses.
- Appendix A contains details of the processing of personal data, including the purpose and nature of the processing, the tipe of personal data, the categories of data subjects and the duration of the processing. <u>Appendix A1</u> contains requirements for the agreed Processing Activities associated with the agreed Service Area(s).
- Appendix B contains the data controller's conditions for the data processor's use of subprocessors. <u>Appendix B1</u> contains a list of sub-processors for the Processing Activities related to the agreed Service Area(s) that the data controller has authorised the use of.

## Appendix A - Information about the processing

A.1.1. The purpose of the data processor's processing of personal data on behalf of the data controller

A.1.1.1 HOSTING AND OPERATION

The purpose of the processing is to provide hosting and operation of the data controller's IT systems, including backup, monitoring, maintenance and support as further specified in the Service Agreement between the parties. This includes specific tasks requested by the data controller.

A.1.2 The data processor's processing of personal data on behalf of the data controller shall mainly pertain to (the nature of the processing)

A.1.2.1 HOSTING AND OPERATION

The data processor will provide hosting and operation of the data controller's IT systems. Thus, the primary purpose of processing of personal data is hosting, including storage of the data controller's personal data, and day-to-day operation, including monitoring, backup and maintenance of the data controller's IT systems containing personal data.

In specific situations, processing may include organisation, structuring, facilitation, temporary storage, filtration, troubleshooting, adaptation or alteration, retrieval, consultation, use, alignment, combination, restriction or erasure of personal data when so required in connection with the data processor's supply of Services to the data controller, or if so, required in order to comply with a specific request from the data controller.



If you are unsure which processing activity(ies) you have agreed with itm8, please refer to your agreement with itm8 under the section "Personal data processing".


## 4 Sub-processor - Appendix B1


By clicking on "Appendix B1", you can access an overview of the sub-processors used by itm8 during the individual processing activities.



Once you have entered into your agreement with itm8, you will be able to log in and see which subdata processors are used for the services that you have agreed with itm8.








When you are logged in, you will be able to see the sub-processors for your agreements by clicking "See sub-processor":

Appendix C contains the data controller's instructions regarding the data processor's processing of personal data, a description of the security measures that the data processor must implement as a minimum, and how the data processor and any sub-processors are supervised. Reference is made to <a href="Appendix C1">Appendix C1</a>, which contains the agreed security measures.



## 6 National safety rules - Appendix D

Itm8 uses the same data processing agreement as standard in all EU countries where itm8's companies are present. If there are special national rules or other relevant requirements in the individual EU countries, these special rules and requirements will be agreed in Appendix D8, which can be accessed via the link in the preamble to the data processing agreement under section 2.11:

 Appendix D contains clauses relating to other activities not covered by the Clauses, including separate national data protection requirements described in <u>Appendix D1</u>.

## 7 Customer responsibility for documentation of the agreement

We reserve the right to change the content that appears on our website "Legal and Compliance", and new versions of our documents will regularly be posted on the website.

It is the customer's responsibility to ensure that the customer has its own version of the data processing agreement with appendices, as the customer undertakes to download the data processing agreement with appendices in the agreement with itm8.

We therefore encourage the customer to download the data processing agreement with appendices immediately after entering into the agreement.
